## Veteran Legislative Bill Tracking 83<sup>rd</sup> Legislative Session (2025) Fred Wagar SFC (R) Veterans of Foreign Wars/Disabled American Veterans

## June 13, 2025

The following is a report regarding the Nevada Legislative Session for 2025 based on bills tracked for the Nevada Departments of Veterans and Foreign Wars and Disabled American Veterans.

The bills tracked were based on Resolutions of the VFW, DAV and the Nevada Veteran Legislative Sessions held in the spring of 2024, which allows veterans, military and their supporters to provide their suggestions for bills for the 2025 legislative session.

During the 2023 session, the United Veterans Legislative Counsel tracked 29 state legislative bills. Their report this year may have more than the 38 that VFW/DAV tracked. Last session, the success rate was 65.5% for veteran and military related bills (19 passed/10 failed. Bill tracking of the United Veterans Legislative Counsel this session may differ slightly from this report. Thank you to UVLC Chair Andy LePeilbet, Secretary Peggy Bohn and UVLC member Norman Allen for all the work they did this year regarding the legislature. A special thank you to Andy who was physically at the Legislature nearly every day advocating for our veterans.

You will see bills related to developing compacts with other states for certain careers. These were tracked as they relate to certain individuals, especially spouses of service members who may be in a licensed vocation in another state but then have to start over when moving to Nevada. When passed, these laws would allow licensing obtained in another state to be credentialed in Nevada.
